Q: It says to fill out in Section A, Block 10. Are there any amendments?

Section A, question 10 pertains if there are any amendments. If there are no amendments, the vendor can simply type or write in N/A.

Q: Is there any benefit in turning the proposal in early in regards to being granted the contract?

In regard to Section A, question 9 the vendor can type or write in 0 for the calendar days as there is no discount. There is no benefit in turning the proposal in earlier than the announced due date of July 17, 2025.

Q: To respond to the RFP, does the offeror need to be licensed as an LSOTP, or can the offeror also be an ALSOTP under the supervision of an LSOTP?

Sex offense treatment is provided by a master's or doctoral level practitioner, who is licensed by their state's regulatory board and adheres to the established ethics, standards, and practices of state regulatory of state sex offender management board (where applicable). The individual shall practice within the generally accepted standards of practice of the individual's mental health profession, adhere to the Code of Ethics and Practice Guidelines published by the Association for the Treatment and Prevention of Sexual Abuse (ATSA), and demonstrate competency according to the individual's respective professional standards and conduct all evaluations/treatment in a manner that is consistent with the reasonably accepted standard of practice in the sex offender evaluation/treatment community.

Q What are the specific requirements and considerations for choosing a location to deliver treatment services?

A vendor must be capable of providing services within a geographic area encompassing El Paso County. The vendor and any proposed subcontractor must maintain an acceptable facility (office) located within the defined catchment area of El Paso County.
